A Year of Challenge, Adaptation and Resilience

Reflecting on a year that posed many unanticipated challenges for its members, which were responded to with powerful resilience, **Ballina Chamber** is looking ahead to a year of continuous adaptation but with some glimmer of hope for sectors adversely affected by the pandemic once the escalation of the virus can be tackled and vaccines more widely distributed.

Reviewing the outcomes of 2020, **Chamber Manager Mags Downey Martin**, said:

"Little did we know that the last weekend in February 2020 as Other Voices descended on our town, bringing hundreds of people and musicians and artists into Ballina and North Mayo, that that would be the last big party, in a town that loves to party.

COVID-19 was not even in our vocabulary when we set our plans for 2020, yet, by March, it was a term that the entire nation became familiar with. With our newly elected Chamber President, Gerry Luskin taking over the reins from outgoing President Hugh Rouse, little did we anticipate that we would be conducting our business out of the office; our team would be working remotely and our links with our members would be via computer screens.

Government intervention, via the Temporary Wage Subsidy Scheme (TWSS), the Pandemic Unemployment Payment (PUP), Budget 2021 interventions, enabled many business doors to remain open but there is still a battle to be fought to return to pre COVID-19 status, as the Chamber continues to lobby for a widening of existing financial supports as our members say the supports are too restrictive. We call on Government to substantially rethink and refresh the range of COVID-19 supports available to businesses over the coming months.

"The distribution of the vaccine offers a glimmer of hope and our call to the entire population of the West region is to do everything within their power to prevent the spread of the virus so that our economy can revert to some form of operational normality in the shortest possible timeframe.

I would like to acknowledge and thank outgoing Chamber President Hugh Rouse (2018-2020) who was a great support to me and chamber staff during his term. Hugh's presidency resulted in a collaborative project in bringing Other Voices to Ballina, continued lobbying of the TII (Transport Infrastructure Ireland) Ballina Street Festival 2019, and ensuring North Mayo is represented on Mayo County Councils Strategic Policy Committees with 5 out of 6 representatives on the committees."

Describing 2020 as a year that was very different but rewarding from a Chamber attainment perspective,

Mags Downey Martin stated:

"Despite the disruption of COVID-19, we managed to deliver a continuous service to our members in 2020, albeit mostly from our virtual desks.

We do look forward to returning to our desks in a full-time capacity sometime in 2021. I would like to acknowledge and Thank my Chamber network colleagues and Chambers Ireland who have been an invaluable support to Ballina Chamber throughout 2020."

Key Achievements

- Ballina Chamber maintained real-time communications with companies at the onset of and throughout COVID-19 to ensure that the supports on offer from Government were relevant and structured appropriately to meet its members' needs.
- 30 business seminars and workshops on a very wide range of educational and information topics were delivered via Webinars.
